**With the signing of this Contract, the Purchaser/s acknowledge that they have read this Contract in its entirety and agree to abide by all stipulations contained herein:**

acknowledge the stud fee for this stallion during the year 2\_\_\_\_\_ is \$\_\_\_\_\_. Purchaser/s are aware that a **Booking Fee of \$250.00** is required upon YL's receipt of this completed Contract, and that the remaining balance of the Breeding Fee must be paid in full as well as an Equitainer Deposit fee in the amount of \$250.00 **PRIOR** to requesting a Cooled Semen shipment. (NOTE: The Booking Fee is non-refundable; the Equitainer Deposit is refundable when the Purchaser/s Veterinarian declares the mare in foal and notifies YL's

Stallion Manager, provided the Equitainer and its internal accessories were returned intact and undamaged following insemination.) The attending Veterinarian or Technician responsible for inseminating the mare is requested to return the Equitainer to YL Ranch within 3 days via FedEx 2-day Air following completion of insemination. Any delay returning the Equitainer in excess of 3 days will result in a **penalty charge of \$25.00 per day, charged to Purchaser/s**. The **fee for purchasing cooled transported semen is \$175.00 for the first shipment**. If additional shipments are required **within the same heat cycle, the charge is reduced to \$100.00**.

If the mare fails to conceive and an additional shipment is required for the **following** heat cycle, the shipment charge will revert back to the original \$175.00 with the same reduction to \$100.00 as before, should additional shipments within that same heat cycle be required. Purchaser shall bear the cost of all FedEx shipping charges incurred in receiving and returning the Equitainer and its accessories, and accepts all liability for loss or damage to it and/or the internal packaging components contained therein. YL Ranch is granted permission to use the

Name on Card:\_\_\_\_\_ for FedEx shipping purposes. Purchaser assumes all responsibility for having the mare/s pregnancy-checked by ultrasound at 18 days following the last insemination and if in foal, is advised to have the mare/s checked again at 45-days to confirm a continuing pregnancy. To insure Purchaser/s "Live Foal Guarantee/s" and assurance of a rebreed for said mare/s or a substitute the following year if necessary, YL's Stallion Manager/Breeding Staff must be kept current on the mare/s continuing condition after declared in foal, and also when the mare foals and condition of the foal at birth.

**Preferred Collection & Shipping Days** are Monday, Wednesday, Friday, and if necessary, Saturday's will be considered. Same-day shipping **may** be given in an emergency, but advance notice is definitely preferred. All semen requests should be received by 9:00 a.m., CST. Our airport does not offer counter-to-counter service.

YL RANCH COOLED TRANSPORTED SEMEN CONTRACT, CONTINUED

**NOTE:** Semen is shipped with the understanding that it is to be used solely to breed to the mare named in this Contract, and no others. Any attempt to use any portion of semen shipped to Purchaser/s to breed any mare other than the designated mare named in the Contract shall automatically terminate all obligations of the Stallion Owner/s, Sharon O. Matthews, YL Ranch and YL Arabians, including but not limited to any live-foal guarantee, rights to additional semen, rebreeding rights, and the responsibility to register any offspring produced by the use of the semen, including the original intended foal. All of the Purchaser/s rights provided by this Breeding Contract/Agreement shall be forfeited and the Purchaser/s shall be liable for the amount up to the cost of breeding for every unapproved mare inseminated whether a foal is produced or not, and legal relief will be sought by the Stallion Owner/s and the Stallion Manager for **all** violations. Also, the Stallion Owner/s, Sharon O. and John A. Matthews, YL Ranch/YL Arabians or their agents or employees nor any Veterinarians or Breeding Technicians assisting with the collection, evaluation, or shipping of semen guarantee the conception rate, quality, or productivity to be obtained in connection with the use of its products or recommended techniques.

**Payment of Fees:** The required Non-Refundable \$250.00 Booking Fee (which is a portion of the Breeding Fee), the balance of said Breeding Fee, and the refundable \$250.00 Equitainer Fee may all be paid online by utilizing the "Pay Pal" option on the YL Ranch website. Purchaser/s who prefer to forward a personal or business Equitainer Deposit check instead (which will not be cashed, but rather retained at YL Ranch until the undamaged Equitainer is returned and the mare/s declared in foal) may do so by making the \$250.00 check out to **YL Ranch** and forwarding it to Sharon O. Matthews, YL Ranch, P.O. Box 818, Albany, Texas 76430 **prior to ordering the first semen shipment.** The chosen stallion's semen will not be collected or shipped unless both the Equitainer Deposit and total Breeding Fee has been paid in advance, **NO EXCEPTIONS!**

This Contract constitutes the entire agreement between the parties hereto and may not be modified except in writing and signed by all parties hereto. This Contract shall not be assigned or transferred by any of the parties hereto without the consent of the other. If the mare/s will be re-bred and the Purchaser/s fail to contact Sharon O. Matthews the following year, then any and all fees shall not be refundable and this Contract is thereby canceled.
