YL Ranch

- Facility USDA approved for export.
- Negative coggins (within last six months) required before stallion will be granted access to facility.
- Stallion owner will be financially responsible for necessary diagnostic testing.
- If boarding is necessary, the stallion owner will be responsible for stallion boarding fee, \$500.<sup>00</sup> per month prorated to reflect the length of the stay.
- Stallion owner will be billed for farrier, veterinary care, and incidentals.
- Stallion owner must provide a sanitary Missouri model artificial vagina that is dedicated for use with this particular stallion.

At Customers Facility

- Customer is responsible for USDA compliance.
- Customer is responsible for all diagnostic testing.
- Travel expenses, in addition to the cryopreservation fee, will be assessed and an itemized bill sent to the stallion owner.
- Suitable collection of the semen sample is the responsibility of the customer.
- YL Ranch reserves the right to refuse mobile service to any facility that fails to maintain a minimum standard of acceptability and utility access.
- Scheduling requires a minimum commitment of three stallions per facility

Cancellation Policy: All fees are non-refundable. 24 hours advance notice is required for cancellation of services. Otherwise, services will not be rescheduled without negotiation and payment of a new contract.

Ownership Of Samples: Any samples produced from this test freeze are not the property of the stallion owner; they will all be destroyed during the evaluation process.

Ownership Of Data: The data gathered from the evaluation of the samples will be the property of the stallion owner. YL Ranch will furnish the stallion owner with a report that includes the raw data, an evaluation of the cryopreservation performance, as well as suggestions concerning future cryopreservation. YL Ranch also reserves the right to use, interpret, and report any data gathered.

Privacy Policy: Every reasonable measure will be taken to protect the anonymity of the stallion and test results, unless the stallion owner grants YL Ranch written permission to release such information.

This agreement applies to the cryopreservation of a single ejaculate from the stallion listed above. All due diligence and personal supervision is exercised in taking quality care of on-premise horses by YL Ranch owners, employees, and their agents, but said individuals cannot be held responsible or liable for any disease, accident, injury or death of client animals or damage to cryopreserved samples while in the custodial care of YL Ranch.
